Learned Government Advocate (Crl.Side) appearing for the respondents-Police, on instructions, submitted that investigation in Crime No.48 of 2024 is over and charge-sheet has been filed through e-filing on 10.07.2025 *vide* No.LTN20230000134C202500045 before the XVII Metropolitan Magistrate, Saidapet, Chennai.

Considering the facts and circumstances of the case and also considering the submissions made by the learned Government Advocate (Crl.Side), this Court is of the view that since the investigation is over and charge sheet has been filed before the jurisdictional Court, there is no necessity to transfer the investigation from the file of the respondent-
