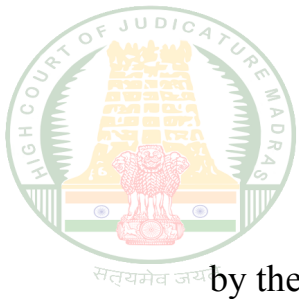

ORDER

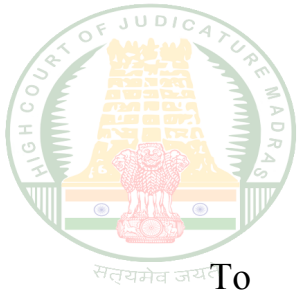
This Criminal Miscellaneous Petition has been filed to exempt the petitioner from surrendering before the trial Court.
