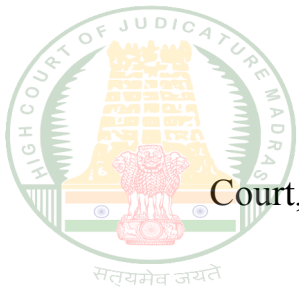

7. The District and Sessions Court, Vellore is directed to take up the G.W.O.P.No. 64 of 2024 and dispose of the same expeditiously, in a manner
