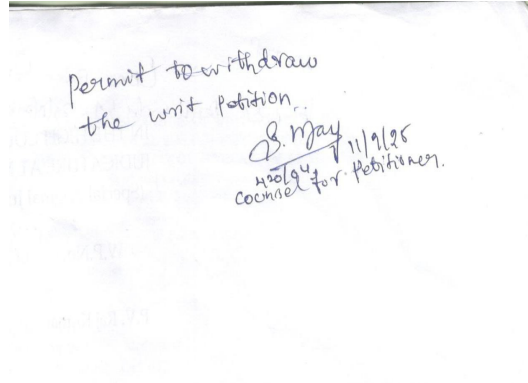
2. Learned counsel for writ petitioner has made an endorsement in the case file and a scanned reproduction of the same is as follows:
