T.S.No.216/5 measuring 6614.478 sq.ft equalent to 614.5 sq.mtrs in

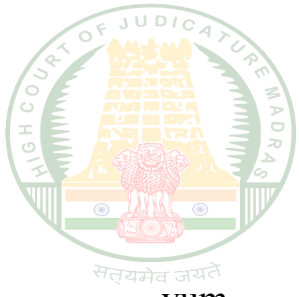
Velacherry which had been acquired by the High Ways Department. A

3. A Common Judgment which was passed in C.S.No.510 of 2006 and O.P.Nos.735 and 736 of 2024 by a Single Judge of this Court on 07.03.2025 wherein, consequent to Mediation, a decree had been passed dividing the aforesaid amount to each one of the claimants. This application has therefore filed to withdraw the share of this claimant which amount is lying in the Court deposit. The Judgment dated 07.03.2025 is still in force and I am not informed about any appeal being filed challenging the same. As a matter of fact, it has been passed pursuant to the settlement reached in Mediation and therefore there is remote possibility of an appeal ever being filed.

4. In view of that particular fact, this application stands allowed.
