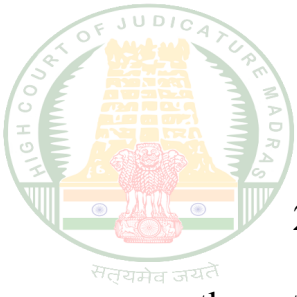

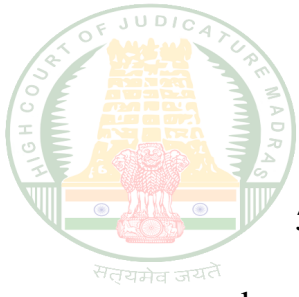

2.
