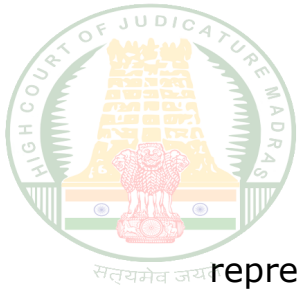

Whether or not private respondent has encroached upon petitioner's land and using the same for the purpose of sewage outlet is the matter to be considered by the appropriate civil Court and not by this Court.
