Learned Senior counsel appearing for the appellant submitted that she is not pressing the relief sought for in the writ appeal.

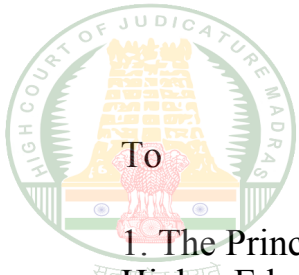
