2. Learned counsel for the petitioner would submit that he has sent representation on 13.05.2025 seeking promotion for the post of Livestock Inspector in the Animal Husbandry Department.

3. At this juncture, learned Special Government Pleader would submit that the petitioner is claiming promotion under the inservice candidate quota and the petitioner's representation had already been considered by the 2nd respondent.
