issuance of a Writ of Mandamus, directing the respondents herein to dispose of the representation dated 12.10.2024 submitted in person and received by them.

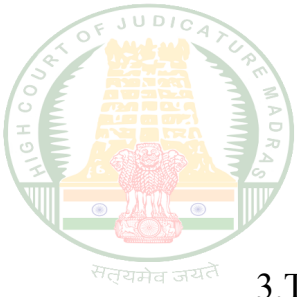
