ORDER

This Contempt Petition is filed complaining disobedience of the order dated 09.05.2025 passed in W.P.No. 17451 of 2025.

2. The grievance of the petitioner in the Writ Petition was that the quarry lease granted to 5th and 6th respondents is to be suspended for certain violations made by them. However, in view of the submissions made by the official respondents that the lease period granted to the 5th and 6th respondents in the Writ Petition was expired on 06.12.2024 itself and further instructions were given that there is no quarry operation was carried out after the expiry of lease period, the Writ Petition was disposed of on 09.05.2025.

3. The learned counsel for petitioner would submit that even after the disposal of Writ Petition, the illegal quarrying activities are undertaken by some private persons. If any such illegal quarrying is carried out, it is for the



petitioner to make necessary complaint before the authorities and to proceed in the manner known to law. This Court does not see any violation or disobedience of the order passed in the Writ Petition. Accordingly, this Contempt Petition is dismissed.
