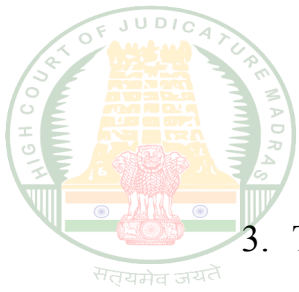

To which, learned Additional Government Pleader for respondents would submit that the above request would be considered and certified copy of the order/award would be furnished at petitioner's cost.

4. In view thereof, the writ petition stands disposed of. The respondents shall consider petitioner's request and issue certified copy of the order/award at petitioner's cost, within a period of two weeks from the date of uploading of web copy without waiting for receipt of certified copy.
