(Order of the Court was made by the Hon'ble Chief Justice)

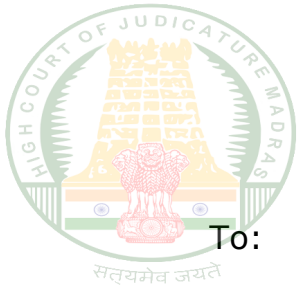
Heard Mr.Krishna Ravindran, learned counsel for the applicant;
