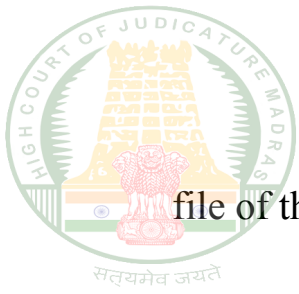

3. The petitioner-wife seeks transfer on the following grounds:

(i) The petitioner and her minor girls are living at Thanjavur and the children are studying there.

(ii)The respondent-husband has not been giving any maintenance either to the petitioner or her children.

(iii)Since the matter is pending before the II Additional Family Court, Chennai, she has to travel from Thanjavur to Chennai leaving behind her children.
