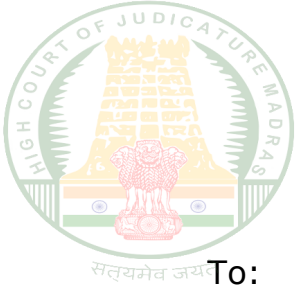
3. Therefore, the corrected order is passed now, that "the Registry is directed to post this appeal before the concerned Bench".
