This Civil Miscellaneous Petition has been filed, seeking to condone the delay of 105 days in filing the appeal, challenging the award dated 09.01.2025 in M.C.O.P.No.573 of 2023 on the file of Motor Accident Claims Tribunal, Special Sub Court No.1, Motor Accidents Claims Petition, Small Causes Court, Chennai.
