There is an omission in the order dated 12.12.2024. Hence, the present petition has been filed for amendment.

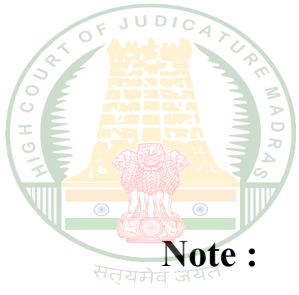
