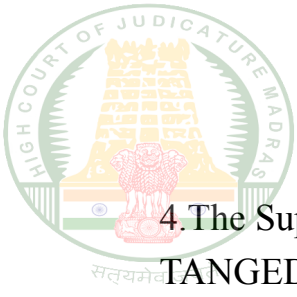

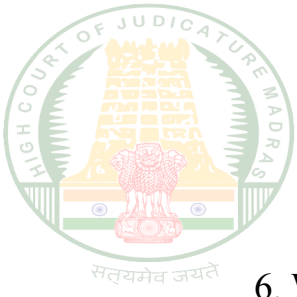


2. It is not disputed that the petitioner has commissioned the solar power plant and it is working. The liability of the first respondent to pay is also not in dispute.

4. The learned counsel for the petitioner submitted that the original documents will be submitted before the respondents.

5. Considering the same, there will be a direction to the first respondent to refund the security deposits with appropriate interest as provided in the contract if there is no legal impediment, within a period of eight weeks from the date of receipt of copy of the order.

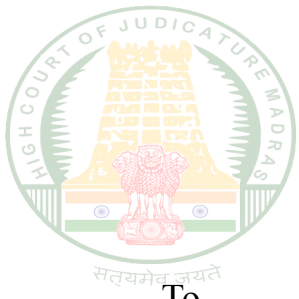
