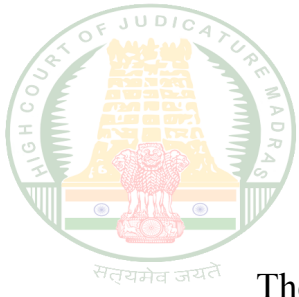
PRAYER
