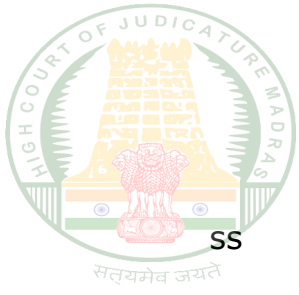
ORDER

We find that certain representations have been made. The Collector is directed to issue necessary direction to the concerned agency to look into the grievance and if the connecting roads need any repair to provide connectivity, the same to be undertaken on priority basis to ensure that the connectivity/access is provided. Disposed of. No costs.
