2.The petitioner had submitted an online application on 16.06.2022 for the aforesaid purpose. Since the same has not been considered till date, the petitioner has filed this writ petition.

3. Mr.S.Arumugam, learned Government Advocate, accepts notice on behalf of the first respondent. Mr.R.Venkatesa Perumal, learned Government Advocate (Crl.Side) accepts notice on behalf of the second respondent.

4.No prejudice will be caused to the first respondent if the said authorities are directed to survey and demarcate the boundaries of the petitioner's property, morefully described in the prayer to this writ petition, after hearing the objections if any from the neighbouring land owners as well as any other party as they deem fit. Accordingly, this writ petition is disposed of in the following manner:-

(a) Before surveying the lands in question, the first respondent is directed to issue notice to the neighbouring land owners and also to any other party, if they deem fit to put on notice.

(b) After receiving objections if any and after considering the same, the first respondent shall conduct survey and demarcate the boundaries of the property, morefully described in the prayer to this writ petition, on merits and in accordance with law, within a period of twelve [12] weeks from the date of receipt of a copy of this order.

(c) If the need arises for police assistance and on a request made by the first respondent, the second respondent shall render police assistance for the effective implementation of this order.
