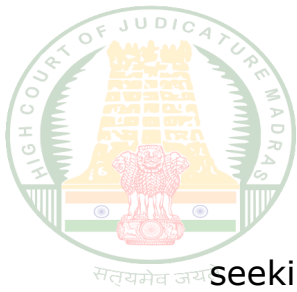

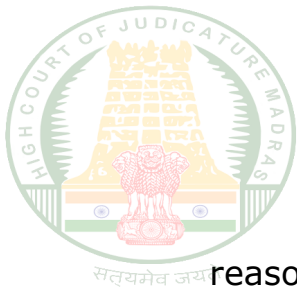

Secondly, once there is an interim order passed by this Court when the revision petition is pending, second petition on the same cause of action would not be maintainable.

3. If the grievance of petitioner is that the revision petition has not been disposed of finally till date, it is for petitioner to approach the concerned authority than coming to this Court. Thus, no relief can be granted in this petition.

4. Petition is dismissed. There shall be no order as to costs. Consequently, all the interim applications are also dismissed.
