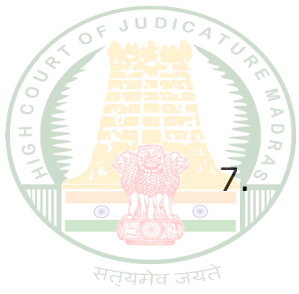

When the captioned 'writ petition' [hereinafter 'WP' for the sake of brevity] was taken up for hearing, Mr. P. Sidharthan, learned counsel on record for writ petitioner, submitted that S.F.No.701/6A in ELGI Nagar Phase I, Vellalore Village, Coimbatore (South) Taluk, Coimbatore District, belongs to writ petitioner, whereas, it has been wrongly described as the land which is a vaikkal/pathway and as land which is under encroachment.

Owing to this narrative, instead of going through a cumbersome process of amendment, learned counsel on record for writ petitioner sought leave of this Court to withdraw the captioned WP but made a plea to preserve all the rights and contentions of the writ petitioner to come back to this Court on the same issue with correct description. 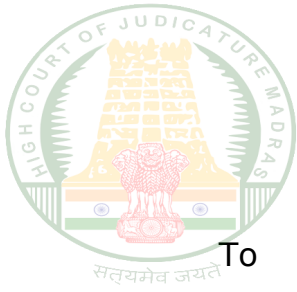
