5. This Writ Petition is disposed of with the above directions. No costs.

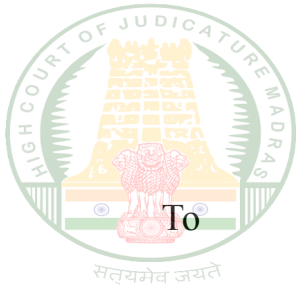
