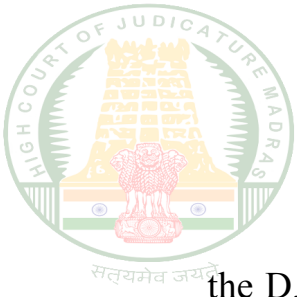
ORDER
