No. Me.Po/Na.Mi.Pa.Va/ Ni.Pi.2/ NiPi2/ /Ko.Mu.Pa dated 26.12.2016 rejecting the petitioners representation and finalising the seniority list of the Field Assistants in the Namakkal District and quash the same and direct the respondents to refix the seniority of Field Assistants on the basis of cyclical method as done in the case of Assistant Engineers under the proviso to Regulation 97 (a) to the Tamilnadu Electricity Board Service Regulations
