3. Petition is disposed. There shall be no order as to costs.

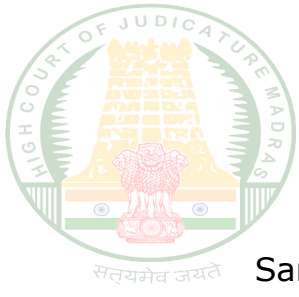
