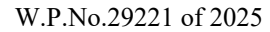

ORDER

2. The learned counsel for the petitioner would further submit that the petitioner has already deposited 10% of the disputed tax pursuant to the interim order dated 05.08.2025.

3. Considering the above submissions, liberty is given to the petitioner



to file an appeal before the Appellate Authority within a 30 days from the date of receipt of a copy of this order.

4. If the petitioner files such an appeal within such time, the Appellate Authority shall dispose of the appeal on merits after hearing the petitioner without reference to limitation.

5. In case the petitioner fails to comply with the same, the respondents are at liberty to proceed against the petitioner in the manner known to law.

6. Accordingly, this Writ Petition stands disposed of. Consequently, connected miscellaneous petition is closed. No costs.
