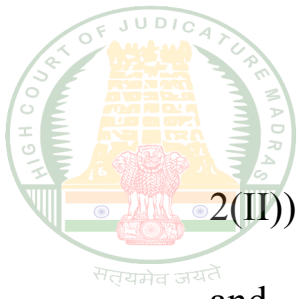

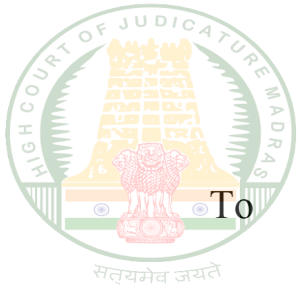
2. Without making a proper representation to the concerned authority, the petitioner has rushed to this Court. The Writ Petition is pre-mature.
