- (2) With the consent of the learned counsels on either side, the writ petition is taken up for final disposal at the admission stage itself.
- (3) The writ petition is filed for a mandamus directing the respondents to dispose of the petitioner's representation dated 10.06.2025 within a stipulated period of time.
- (4) When the matter was taken up for hearing, the learned Special Government Pleader appearing for the respondents 2 and 3 submitted that Section 82



proceedings have been initiated against the 4th respondent and an Enquiry

Officer was also appointed vide order dated 16.07.2025, with a direction to
