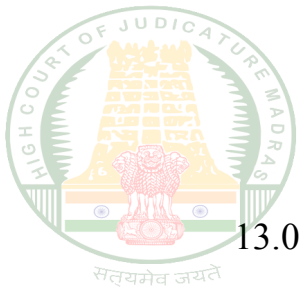

This writ petition has been filed to directing the 3rd respondent to implement the communication given by the 2nd respondent dated

2. Mr.C.Jayaprakash, learned Government Advocate, takes notice on behalf of the respondents 2, 3, 5 & 6 and Mr.P.Harish, learned Government Advocate, takes notice on behalf of the respondents 1 & 4.

3. Today, none appeared for the petitioner. However, the learned Government Advocate appearing for the respondents would submit that the present issue is pertaining to the disposal of representation filed by the petitioner on 31.10.2024.

4. Further, he would submit that subsequent to the filing of aforesaid representation, the 2nd respondent vide proceedings dated 13.02.2024, had directed 3rd respondent to take action on the petitioner's representation.
