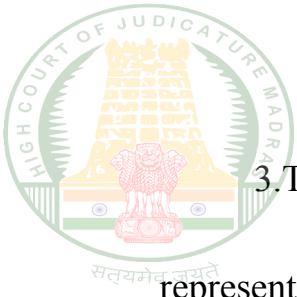

### **ORDER**

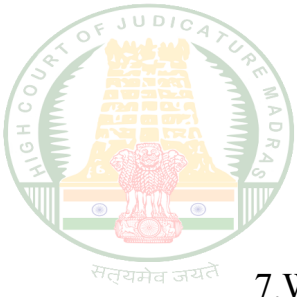


3. The grievance of the petitioner before this Court is that the representation of the petitioner dated 20.06.2025 has not been considered by the respondents so far.
