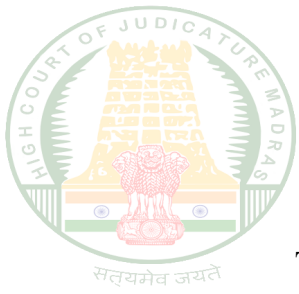

This Contempt petition has been filed for the violation of the orders passed by this Court in W.P.No.30666 of 2012, dated 20.02.2024.

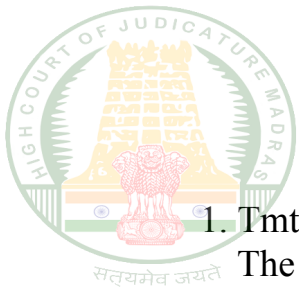
2. No representation for the petitioner.
