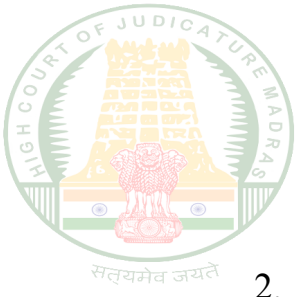

This Criminal Original Petition has been filed seeking transfer of investigation in Crime No.269 of 2024 from the file of third respondent to the file of fourth respondent.

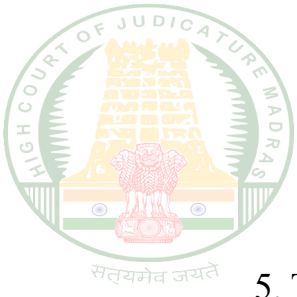
