CMP Nos.22506, 22507 & 22508 of 2023 in A.S.No.218 of 2017 &

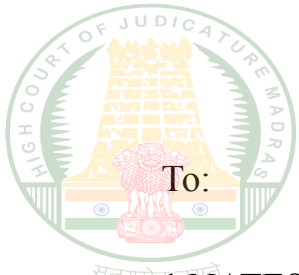
CMP.Nos.22524, 22551 & 22554 of 2023 in A.S.No.217 of 2017 have been
