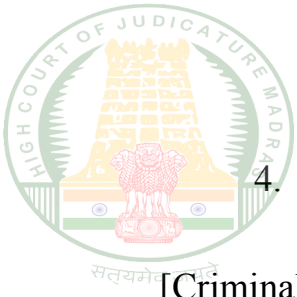

This Criminal Original Petition has been filed to issue a direction to the second respondent to file a Charge Sheet in Crime No.539 of 2024.

2, The case of the petitioner is that on 13.11.2024 at about 2.00 p.m. his son was hit by a vehicle bearing registration No.KA05-QB-6187 Hero Splendor Plus Bike and caused severe injuries, due to which his son died on the spot. In this regard, the petitioner had preferred a complaint before the second respondent.
