(Order of the Court was made by R.SUBRAMANIAN, J.)

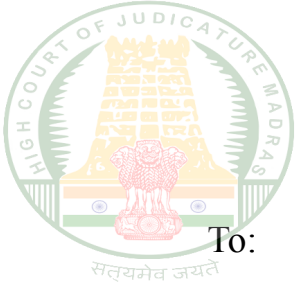
It is stated that the appending structure has been removed and it is no longer there. The learned counsel for the petitioner also acknowledges the same. Hence, this Contempt Petition is closed.
