**ORDER**

This petition has been filed to withdraw H.M.O.P.No.261 of 2024 from the file of the II Additional Subordinate Court, Coimbatore and to transfer the same to the file of the Subordinate Court, Alandur.

The learned counsel appearing for the petitioner would submit that the respondent/husband filed a petition for restitution of conjugal rights before the II Additional Subordinate Court, Coimbatore and the same is pending in H.M.O.P.No.261 of 2024.
