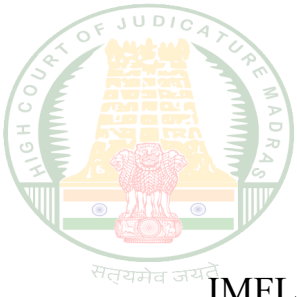

ORDER

The petition for bail for the alleged offence under Sections 4(1)(C)
r/w 4(1-A)(ii) of Tamil Nadu Prohibition (Amendment) Act 2024 in Crime
No.262 of 2025, registered on the file of the respondent police.

2. The petitioner was found in possession of 12 bottles of 180 ml IMFL. She was arrested on 30.07.2025.

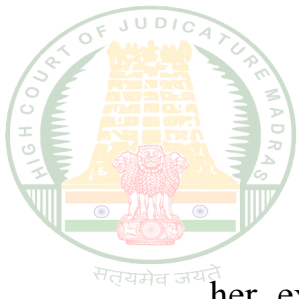

3. The learned counsel appearing for the petitioner states that the petitioner is an innocent person and she has not committed any such offence as alleged by the prosecution. He further submitted that the petitioner is ready to abide by any stringent condition that may be imposed by this Court. Hence, he prayed for grant of bail to the petitioner.

4. The learned Government Advocate (Criminal Side) appearing for the respondent police opposed for grant of bail stating that the petitioner is having seven previous cases and she is an habitual prohibition offender.

5. Heard both sides and perused the materials available on record.

6. Considering the fact that the petitioner is a female and she is in prison for nearly 25 days, this Court is inclined to grant bail to the petitioner with certain conditions.

7. Accordingly, the petitioner is ordered to be released on bail on her executing a bond for a sum of **Rs.25,000/- (Rupees Twenty Five Thousand only)** with **two sureties**, each for a like sum to the satisfaction of the learned **Judicial Magistrate-I, Tiruvannamalai District**, and on further conditions that:

[a] the sureties shall affix their photographs and Left Thumb Impression in the Application for Surety ship [Judicial Form No.46 annexed to 'The Criminal Rules of Practice, 2019']. The learned Magistrate shall obtain a copy of any one of the identity proofs to ensure their identity;

[b] **the petitioner shall report before the respondent police daily at 10.30.a.m., until further orders;**

[c] On breach of any of the aforementioned conditions, the learned Magistrate/Trial Court is entitled to pass appropriate orders against the petitioner in accordance with law as if the aforementioned conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in **P.K.Shaji vs. State of Kerala [(2005)13 SCC 283]**;

can be registered under Section 269 of B.N.S.
