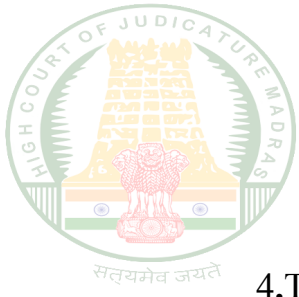

COMMON ORDER
