The learned counsel appearing for the petitioner would submit that the respondent/husband filed a petition for divorce before the Family Court, Vellore and the same is pending in F.C.O.P.No.112 of 2024. The petitioner/wife is living in her parental home at Rajapalayam, Tiruvannamalai District along with her child and she is totally dependent on her parents. In such circumstances, it is very difficult for her to travel 80 kms from Tiruvannamalai to Vellore for attending each and every hearing of the case. Therefore, the case in F.C.O.P.No.112 of 2024 may be withdrawn from the file of the Family Court, Vellore and transferred to the file of the Family Court, Tiruvannamalai.

6. I have gone through the affidavit filed in support this petition and I find merit in the submissions made by the learned counsel for the petitioner/wife.

7. In view of the above and also considering the submissions
