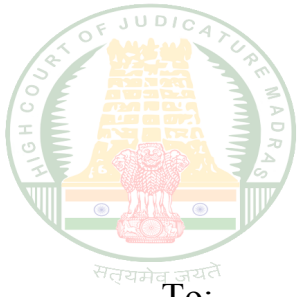
3. Considering the above facts, this Criminal Original Petition is dismissed. However, it is open to the petitioner to participate in the enquiry and prove his innocence.
