He also submitted that the investigation of the case was completed and final report filed in S.C.No.165 of 2023 on the file of the Principal District and Sessions Judge, Thiruvallur; and that the case is posted for examination of L.W.3 to L.W.7.

3. Considering the submissions made, facts of the case and also taking note of the fact that the trial is pending for examination of witnesses, this Court is of the view that the cancellation of the bail granted to the respondent herein at this stage is not necessary.
