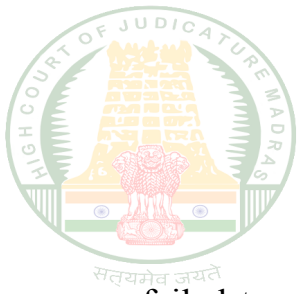

ORDER

The petitioner herein apprehend arrest at the hands of the respondent police for the offences punishable under Sections 318(4) and 351(2) of BNS, 2023 in Crime No.454 of 2025, on the file of the respondent Police, seeks anticipatory bail.

2. It appears that the petitioner had borrowed a sum of Rs.3.5 lakhs and

failed to repay it. Hence, the complaint was lodged by the defacto complainant, based on which, FIR in Crime No.454 of 2025 was registered. Hence, the case.

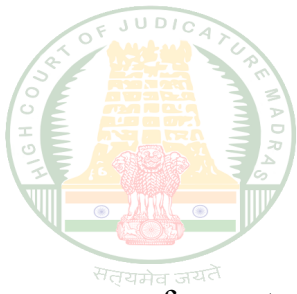
3. The learned counsel appearing for the petitioner states that, due to money dispute, a false complaint has been lodged. Hence, he prayed for grant of anticipatory bail to the petitioner.

4. The learned Government Advocate (Crl. Side) reiterated the prosecution case and opposed for grant of anticipatory bail to the petitioner.

5. Heard the learned counsels on either side and perused the materials available on record.

6. Considering the nature of offence and since, custodial interrogation of the petitioner is not required, this Court is inclined to grant anticipatory bail to the petitioner with certain conditions.

7. Accordingly, the petitioner are ordered to be released on bail in the event

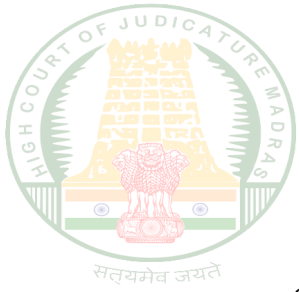
of arrest or on his appearance, **on or before 23.08.2025** before the learned **District Munsif Cum Judicial Magistrate, Kilvelur** on condition that the petitioner shall execute a bond for a sum of **Rs.10,000/- (Rupees Ten Thousand only) with two sureties** each for a like sum to the satisfaction of the respondent police or the police officer who intends to arrest or to the satisfaction of the learned Magistrate concerned and on further condition that:

[a] if the petitioner fails to surrender before the said Magistrate on or before 23.08.2025, this Order shall stand automatically cancelled;

[b] the sureties shall affix their photographs and Left Thumb Impression in the Application for Surety ship [Judicial Form No.46 annexed to 'The Criminal Rules of Practice, 2019']. The learned Magistrate shall obtain a copy of any one of the identity proofs to ensure their identity;

[c] the petitioner shall report before the respondent police daily at 10.30.a.m., until further orders;

[d] On breach of any of the aforementioned conditions, the learned Magistrate/Trial Court is entitled to pass appropriate orders against the petitioner in accordance with law as if the aforementioned conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in **P.K.Shaji vs. State of Kerala [(2005)13**
