Prayer: Writ Petition filed under Article 226 of the Constitution of India praying to issue a Writ of Mandamus, directing the respondents 1 to 6 herein to pay Solatium amount at 30 percentage as per section 23(2) of the Land Acquisition Act, 1894 and an additional amount at 12 percentage per annum as per Section 23(1-A) from the date of Notification of the date Arbitral Award along with interest at 9 percentage for one year from the date of possession and thereafter at 15 percentage per annum till date of actual payment as per section 28 of the said act, 1894 in respect of the petitioners husband land an extent of 4974 Sq.Meters in Sy.No. 211/1B and 1714 Sq.Meters in Sy.No.211/3C of Vedanginallur Village, Thiruvallur District acquired for the purpose of widening Alamelumangapuram-Pakkam Sector of NH-205 in compliance with the Judgement of the Honble Supreme Court of India ordered in case of Union of India Vs.Tarsem Singh.
