ORDER

2. The petitioner has examined herself as PW1. She has produced the computer generated Death Certificate of the deceased and her husband as Ex.P2 and Ex.P1. The legal heirship certificate of the deceased as Ex.P3. On perusal of Ex.P3, shows that the petitioner is the only daughter of the deceased and surviving legal heir of the deceased.

3.The assertions in the petition have been duly proved by adducing oral evidence supported by documents. In these circumstances, the petitioner is entitled to the relief.

4. In view of the above evidence, the Original Petition is allowed granting Succession Certificate in favour of the petitioner, with the power to collect the securities and receive the interest and dividends mentioned in the schedule to the petition.
