**PRAYER:**

Writ Petition filed under Section 226 of the Constitution of India, 1950, pleased to issue Writ of Certiorari Mandamus, praying to call for the records pertaining to proceedings of the 5<sup>th</sup> respondent in Voo. 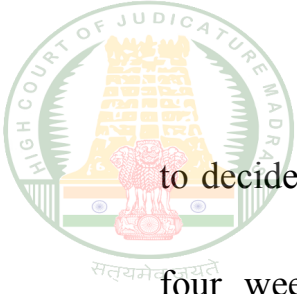

### **ORDER**

Though larger relief has been sought for in the present writ petition, when the matter is taken up for hearing, learned counsel for the petitioner would submit that the tenure of the 5<sup>th</sup> respondent/Panchayat President was got over on 05.01.2025 and hence, liberty may be granted to make fresh representation for name transfer before the 4<sup>th</sup> respondent, who is the authority at present.

2.Considering the submissions made by the learned counsel for the petitioner, without going into the merits of the matter, this writ petition is disposed of granting liberty to the petitioner to make fresh representation before the 4<sup>th</sup> respondent for name transfer. In such case, the 4<sup>th</sup> respondent is directed



to decide the matters on merits and in accordance with law, within a period of four weeks from the date of receipt of a copy of this order. No costs.

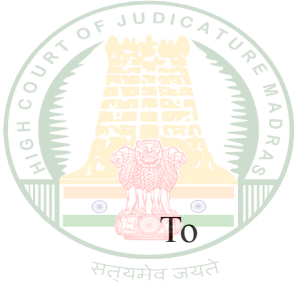
