Notice vide 20/2023, to the defacto complainant through registered post on 08.09.2025. Further, I have filed a Final Report before the Learned Vth Metropolitan Magistrate Court, Egmore through e-filing vide LTN00023201104C202500199, dated 08.09.2025 and the same taken on file and Court R.C.S. number is assigned as RCS No.333 of 2025 and court RCS Notice served to petitioner on 10.09.2025 through register post with acknowledgment due. The petitioner also appeared before the Learned Vth Metropolitan Magistrate Court, Egmore on 23.09.2025 and above case stands posted on 27.10.2025 for filing protest petition."
