It is submitted that after the order passed in Crl.O.P.No.1845 of 2024 by the Hon'ble High Court, Madras, the learned Special Court for trial cases under SC/ST Act (POA), Vellore has returned the final report due to some corrections on various time and the same was rectified and submitted as additional final report before the learned Special Court for trial cases under SC/ST Act (POA) Vellore on various dates ie., 31.03.2024, 28.06.2024, 08.07.2024, 18.09.2024 and 20.09.2024.
