ORDER

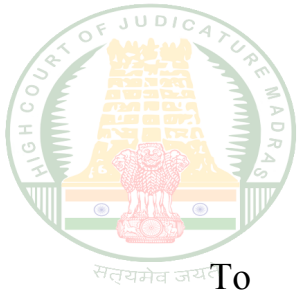
The condition imposed by the Court while granting bail on 23.04.2025 in Crl.O.P.No.8517 of 2025 is sought to be relaxed.
